Our Community Health Workers (CHWs) are trained Philadelphians who live in the same communities they serve. Through both lived and professional experience, they share information and advocate for residents on important health topics such as managing high blood pressure, diabetes, high cholesterol, and mental health.

CHWs also host Community Wellness Workshops at multiple community-based organizations (CBOs), where they offer one-on-one support, including help with utility bills, eviction prevention, and referrals to other services.

The City of Philadelphia provides emergency and temporary shelter for individuals and families experiencing homelessness. Homeless Services administers contracts with various human service organizations to offer short-term emergency housing accommodations based on assessed need. These services aim to resolve immediate housing crises and include case management support to help households secure appropriate long-term housing. Emergency housing services include:

- Temporary shelter
- Ongoing case management services
- Assistance with obtaining transitional and/ or permanent housing
- An optional savings program which allows households to save a part of their income for future housing expenses

Homestead Exemption Program

The Homestead Exemption reduces the taxable portion of your property assessment, lowering your real estate tax bill. Homeowners can save up to hundreds of dollars each year. 
