Limits and Conditions

- Every licensed Demolition Contractor shall notify the Department in writing within ten (10) days of any change in the information required by the Department as a pre-requisite for securing the License.
- No person or business entity shall act as a Demolition Contractor without a demolition supervisor and site safety manager with the required qualifications on staff at all times.
- Demolition Contractors and subcontractors must have valid licenses. All subcontractors working under a permit must be submitted to the Department.
- Demolition Contractors cannot sell or transfer their license or permit to another person.
- · Demolition Contractors must provide accurate information on any license or permit application with the Department.
- Demolition Contractors must get all required permits for construction or demolition work and comply with approved permit
 documents.
- Demolition Contractors must maintain information at each job site as required by The Philadelphia Code.
- Demolition Contractors must display their Demolition Contractor license number on any advertisements, stationery, places of business, job sites, proposals, and vehicles displaying the business name.
- Demolition Contractors must maintain complete financial and construction records (including plans) for each job performed for four years after completion of the job.
- Demolition Contractors must follow all provisions of The Philadelphia Code.
- Demolition Contractors must remain current on all City of Philadelphia taxes and fines. Failure to do so may result in the denial of permits and/or license renewals.
