RE: Lawncrest Recreation Center Pool Replacement

To the Art Commission:

The City of Philadelphia Capital Program Office, on behalf of Philadelphia Parks and Recreation, would like to submit a request for review of the Lawncrest Recreation Center Pool Replacement project during the Art Commission meeting scheduled for August 13, 2025. This letter precedes the presentation package which will be submitted on August 6, 2025.

The Lawncrest Recreation Center pool is located at 6000 Rising Sun Avenue on a parcel owned by the City of Philadelphia. The pool and associated clubhouse were designed and constructed circa 1969. This phase of the project proposes to replace the existing pool, pool deck, and an adjacent retaining wall and fencing. The construction budget for the project is \$6,000,000.

The existing pool is past the end of its useful life and lacks ADA entry features and a perimeter overflow system. Corrosion in the pool piping is contributing to failure of an adjacent retaining wall. The project will provide a new ADA accessible pool, pool deck shower, a new pool deck, and a new retaining wall with an integrated fence and lighting.

An existing Percent for Art public sculpture on the pool deck, titled "*Underwater Sunscreen*" by Harold Kimmelman, will require relocation during construction. We are in coordination with Creative PHL and PPR to confirm the plan for the existing artwork. Please refer to attached previously submitted letters from Creative PHL regarding the coordination of conservation and new commissions on the property.





SITE - AERIAL VIEW









SITE LAYOUT PLAN



DESIGN PRECEDENT - BRIDESBURG RECREATION CENTER POOL RETAINING WALL




