Commissioner Nasser asked about that safely of the crosswalk in this area. He also asked about a playground area. Applicant explained plan for addressing crosswalk area and reviewed that there is a playground area.

Commission carried conversation address multiple areas they would like to see be developed for when applicants come back to commission for final approval.

John Chin, Executive Director of Chinatown Development Corporation, expressed that OTIS and others have been great partners in this project. He also acknowledges how this project could help Vine Street become the Main Street of Chinatown (00:55:50)

Commissioners Lowe and Nasser asked about restroom and park hours. Applicant reviewed where the restrooms would be located. Applicant stated the park is open but there will be no 24hr access. (01:01:59)

Commissioner Lowe asked who will maintain the landscaping? Applicated stated that they are working with the city and PennDOT to have maintenance agreements put in place. Each entity will have their own agreement.

Commissioner Segall raised questions about how the landscaping would have access to be performed and also water irrigation. Applicant ensured that those details would be written out within the agreements and that there had been water irrigation integrated landscape.

Commissioner Ososrio asked about any additional lighting to be added to protect the pedestrians while navigating? The applicant stated that the lighting infrastructure will be included, however the design will be part of later r phase.
