Vinnie Bagwell stated that additional signage can be installed with a QR code to provide additional information. This has not been designed yet; we are working with Dr. Alexanders biographer that will help with the information provided.

Commissioner Osorio expressed that this artistry is a must in our time and his concern about placing signage too close to sculpture could take away the mobility of the sculpture.
