Commissioner Nasser expressed concerns about children getting hurt by the soccer balls if there was no fencing.

Richard Washington from Logan School Community stated that since he has been there over the years, he has not seen a ball go out in the street to address concerns of the commission. This is expounded on how this project creates more open space for activity.

Commissioner Roesch asked to confirm fencing, seating and percent for art requirements. The Presenter would have to get additional information about percent to art requirements. The fencing will be metal picket fence along the North, west and south side and some chain link near the court. There will be stacked spectator seating near courts. Commissioner asked for dimension plans to be brought back at next review.

Commissioner Lowe asked what the dimensions are from paved area to underside of the structure. The presenter stated that it is at least 20'-0"

The presenter explains more in depth about the community wanting to be able to host pop up shops event in vendor stalls. They will have shade, coverage and electricity.

Commissioner Febo San Miguel asked if the Nicetown CDC will provide administration support. The presenter stated that they currently hold offices down the street.

Commissioner Osorio expressed concerns about lighting and proposal to reconsider the current lighting plan. He stated that this was a wonderful project for the community.

Commissioner Nasser asked how many bike racks will be available and where the trees would be placed. The presents showed the three areas where bikes are located and stated that the canopy trees will be far away from the underpass and showed where new trees would be placed on diagram.

Commissioner Osorio suggested adding lighting to the Nicetown Signage.
