<u>SJU Testimony regarding Bill No. 250804 – Proposed "/UCO, University-Community Overlay District"</u>

Dear Chairperson Lawrence and Executive Director Howell:

On behalf of Saint Joseph's University, which is located in the proposed /UCO, University-Community Overlay District as contemplated by pending Bill No. 250804 (the "Legislation"). For the reasons set forth below, we formally request that the City Planning Commission vote to extend its City Charter review period of the Legislation by 45 days.

- Philadelphia is a city rich in universities, which is counted among the most important
 economic drivers. This legislation would significantly and negatively impact existing
 university real estate assets and balance sheets, consequently affecting the ability to
 borrow, develop new capital projects, expand programs, and provide student need-based
 aid. Therefore, affected universities need more time to study, understand, and respond to
 the potential long-term effects of this legislation.
- Additionally, the ramifications of this legislation could be far-reaching well beyond the 3rd District, for example, if similar legislation is adopted in other Districts or applied to other non-profit entities.
- Finally, the impact of this legislation stretches beyond the 3rd District because it would negatively impact union jobs. Over the past four years alone, SJU has commissioned four major construction projects, resulting in several thousand laborers and millions of manhours working on those projects. Universities are one of the few industries that continue to commission construction projects, especially when there is a downturn in the real estate market. Because this legislation would negatively impact University balance sheets, it would, in turn, harm our ability to commission such projects, affecting laborers throughout the City and the region.

Accordingly, we ask that the City Planning Commission vote to extend its review period by 45 days to allow for greater discussion of this Legislation with the Administration, City Council, and the Law Department.
