Dear Commissioner Raval-Nelson and Ms. Nazario:

I am writing to notify the City of Philadelphia (the "City") of a planned transfer of equity ownership for the nursing facility known as "Maplewood Nursing and Rehabilitation Center," located at 125 West Schoolhouse Lane, Philadelphia, PA 19144 (the "Facility"). This letter constitutes notice of the proposed transaction pursuant to City of Philadelphia ordinance § 6-409, as revised on June 9, 2021 (the "Ordinance").

I. Name, address, and description of the corporate organizational structure of the legal entity seeking to obtain an ownership interest and/or license with respect to the nursing facility.

The Facility was recently acquired by MA Operating, LLC in June 2025. The upcoming transaction is a transfer of equity ownership within the existing membership which will <u>not</u> result in a change in the licensee entity or tax identification number for the licensed provider. This transfer of membership interest does not constitute a change of ownership for Medicare or Medicaid certification purposes. However, pursuant to its regulations, the Pennsylvania Department of Health ("DOH") is requiring submission of a change of ownership application to effectuate the transfer of equity ownership.

While 60% of the total interests in the facility is being transferred, 40% of those are going to an existing owner, while only 20% are moving to a "new" owner. The licensee entity will stay the same.
