RE: Lawncrest Recreation Center Pool Replacement

To the Art Commission:

The City of Philadelphia Capital Program Office, on behalf of Philadelphia Parks and Recreation, would like to submit a request for review of added scope to the Lawncrest Recreation Center Pool Replacement project during the Art Commission meeting scheduled for January 14, 2026. This letter is accompanied by the presentation for review.

The Lawncrest Recreation Center pool is located at 6000 Rising Sun Avenue on a parcel owned by the City of Philadelphia. The pool and associated clubhouse were designed and constructed circa 1969. This added scope includes renovation of existing restrooms, pool attendant office, and storage in the existing building, previously used as a bath house. A deteriorated perimeter brick masonry wall at the entry to the pool will be removed and replaced with an ornamental fence consistent with the new fence approved for the perimeter of the rest of the pool complex. The construction budget for the project is \$600,000.

In the existing condition, none of the existing doorways are ADA accessible. Only one toilet is provided in each toilet room, and one additional toilet is provided in a staff-only area. There are unused shower stalls in each restroom. The renovation will add two additional plumbing fixtures in each gendered restroom, and add a single-user gender neutral restroom. All restrooms will have baby changing tables. All restrooms will meet ADA requirements. The project will update all lighting and ventilation systems.

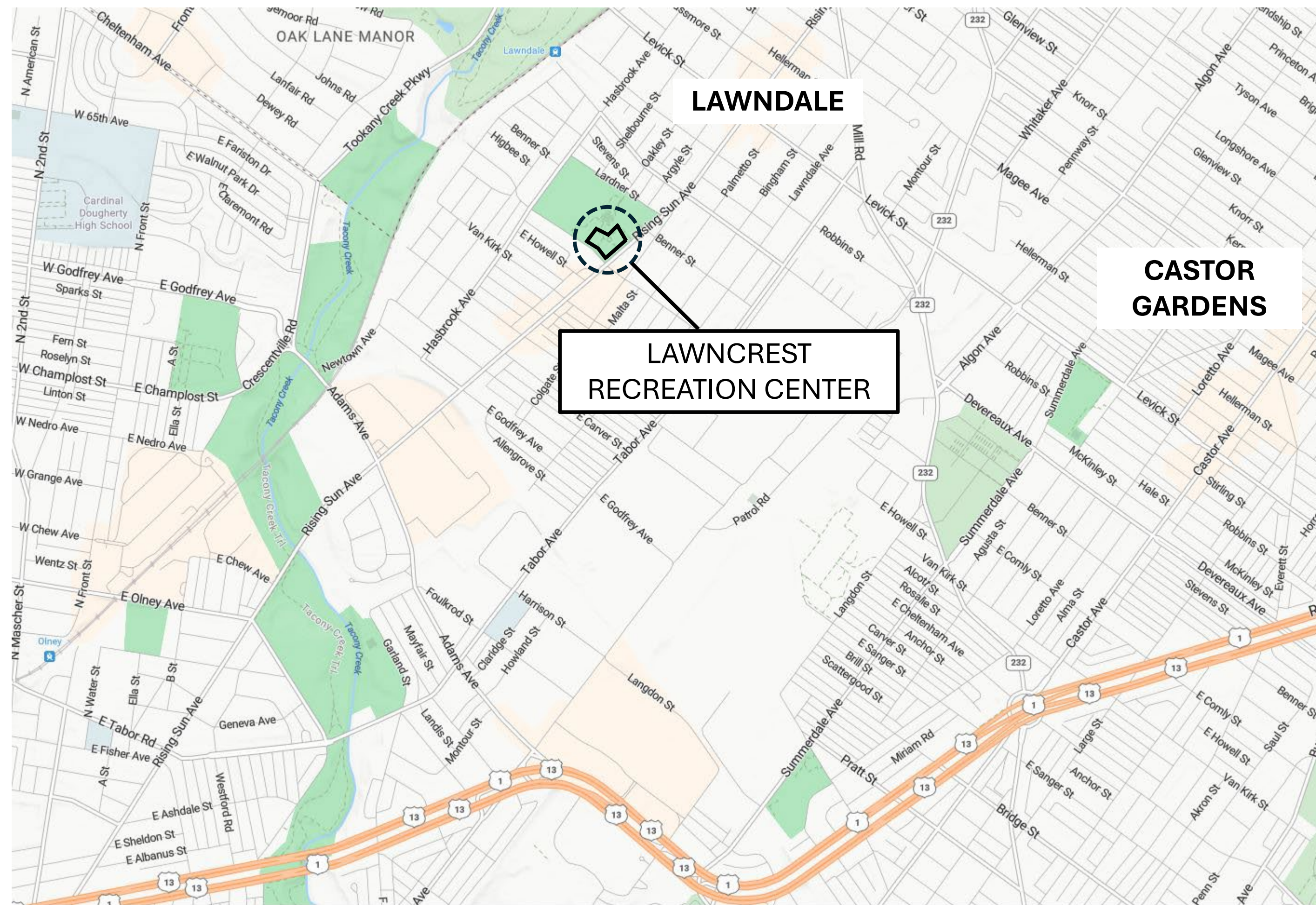

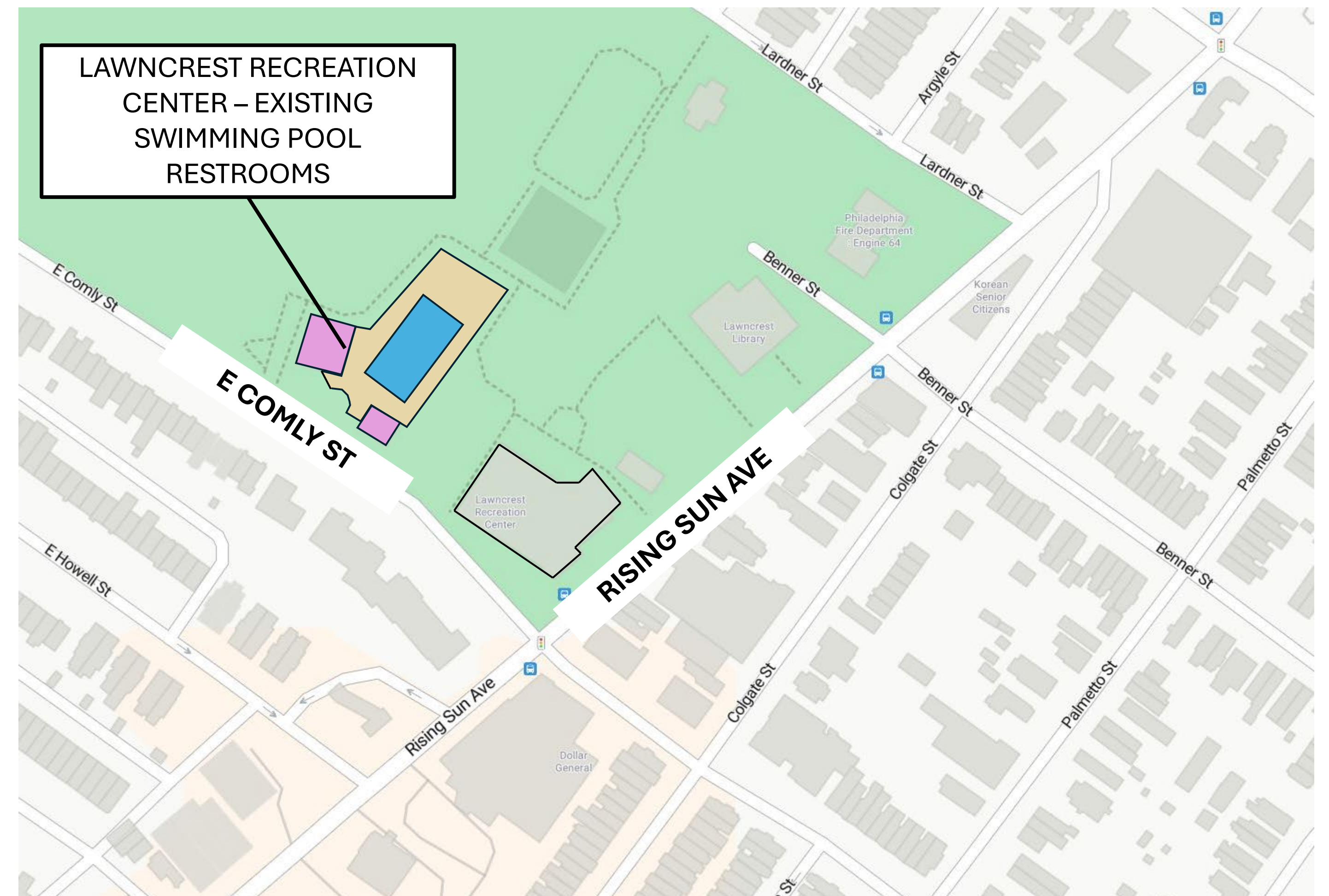

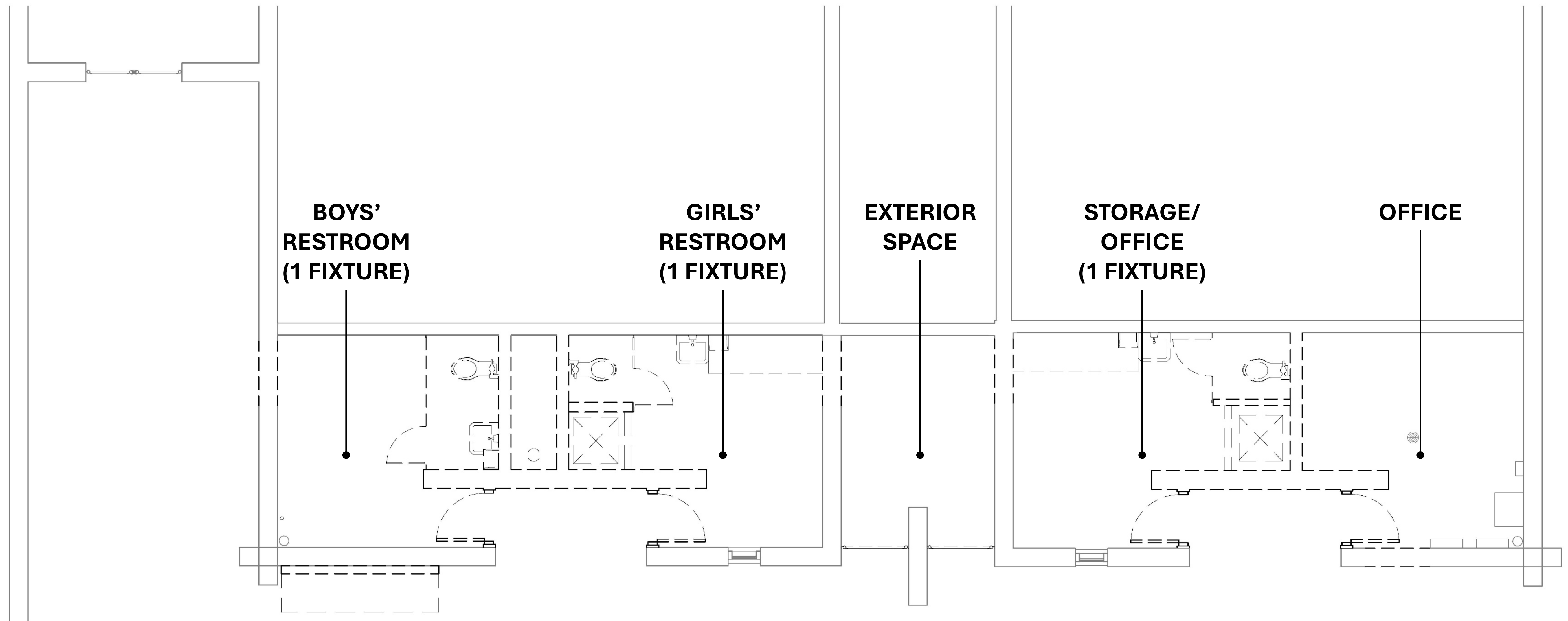

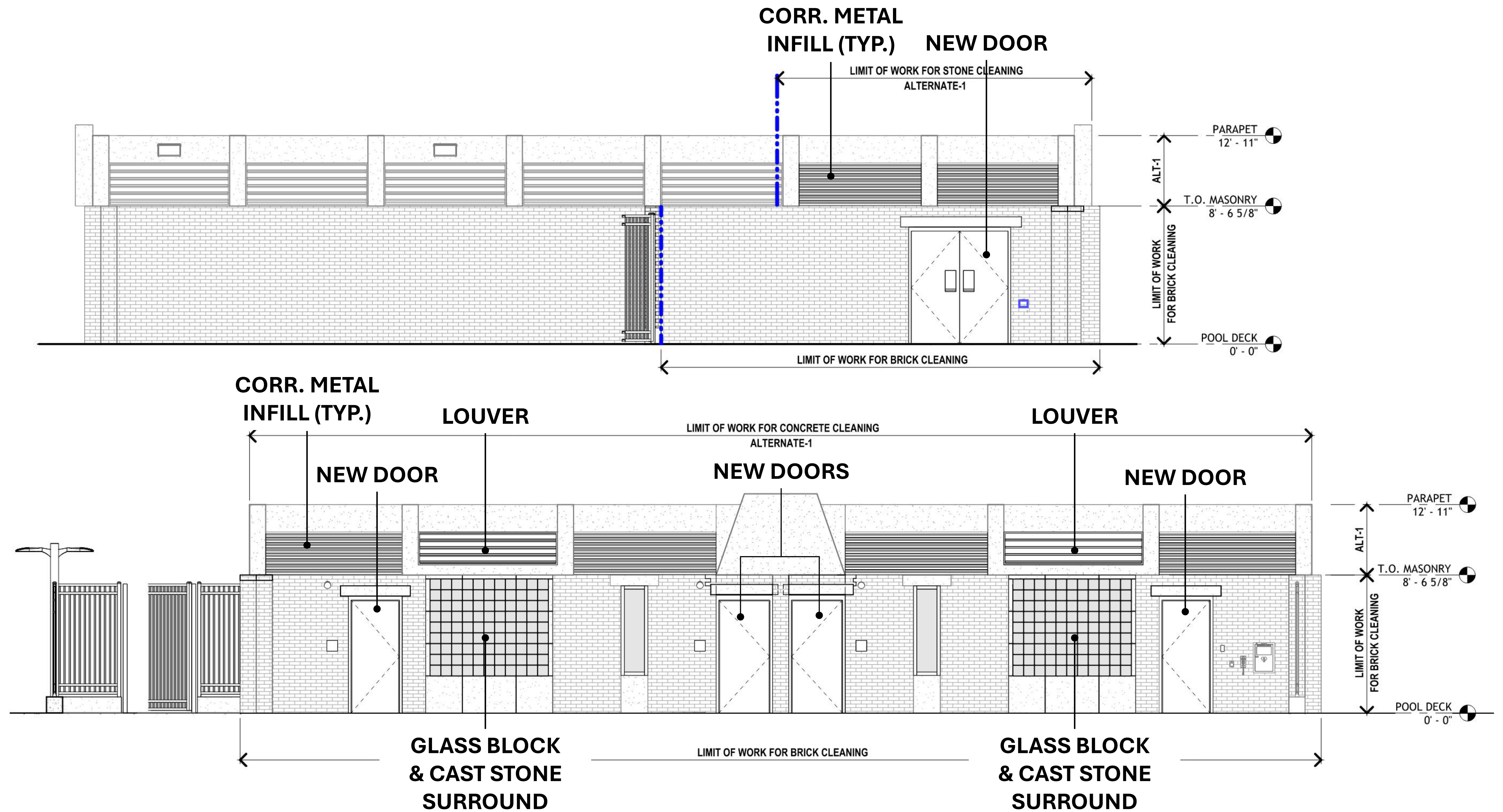

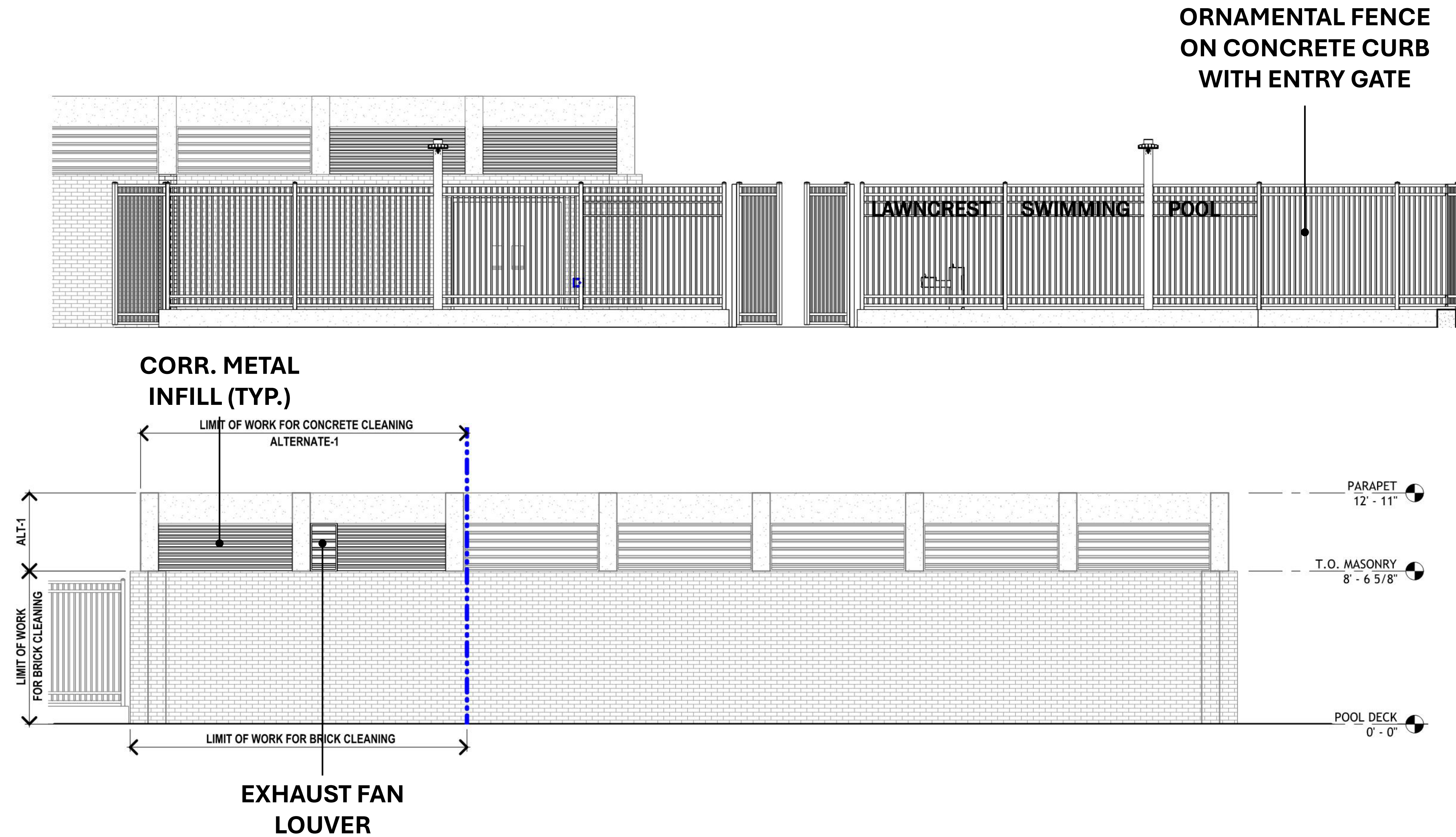
