  - *We want a commitment from the City to make sure SEPTA (or someone) keeps the area clean + maintained.*
  - *Clear traffic signals/flasher points*
  - *Please advise if there will be a consistent clean schedule for the trail.*
  - *I am satisfied so far with the progress. I am not quite there yet.*
  - *Carry ones the mile from Cynwyd Trail to the extent possible. Have a plan for safety, maintenance, etc. Learn from/leverage insights from others, trail communications*
  - *Would like to see diversity among all involved parties*
  - *High priority for me. Safe access from existing bike paths, eg. 53rd & Parkside; Education/signage for cyclists on safe routes to trail*

### ~ Concerns ~

- *No Trails*
- *Noise*
  - *Not immediately*
  - *Think its an interesting idea and the community could use. But security is everything and people have to feel secure if its to be used. Fencing is mandatory*
  - *The trail would cause safety & privacy concerns for the 2300 block of St. Bernard St. Which is historical & private. No Trail!*
  - *My family and I are against the trail. It's very quiet and comfortable. We don't need any loud noises & trash etc. My mother is a senior citizen. And this could bring crime.*
  - *Would not like to have a trail behind my property. Safety, is an issue, trespassing, violence, chaos, trash, unwelcome guests are all concerns. Police/security, not enough in the city already. Safety, safety, safety, safety*
  - *Too much traffic in a small neighborhood. Saint Bernard St is a small street that would bring too much traffic to the neighborhood. There will be extra trash in the streets.*
  - *Concern people that are undesirable coming through the back of our homes. It is not a trail we would use.*
