## Right to Counsel: FY2026 Zip Code Expansion Analysis

### Background

Philadelphia's Right to Counsel (RTC) program provides no-cost legal representation to income-eligible tenants facing eviction in designated zip codes. Pursuant to City Council legislation, the program has expanded progressively since its inception, with zip code selection guided by data analysis conducted by Reinvestment Fund. This document presents the data for the Fiscal Year 2026 expansion.

### Methodology

Reinvestment Fund's analysis ranks each Philadelphia zip code on three indicators: (1) number of eviction filings (2024), (2) eviction filing rate (percent of renter-occupied households subject to an eviction filing), and (3) family poverty rate (2019-2023, most recent available).

Each zip code is ranked 1 through 46 on each indicator, with lower ranks indicating greater need or vulnerability.

The ranks for each indicator are also tallied into a combined rank, giving each indicator equal value – that is, family poverty is weighted the same as the number of eviction filings and the percent of renters facing an eviction. Because there are two eviction related indicators, evictions are more determinative of the combined ranking score.

### Results

Tables 1, 2, and 3 provide the top five zip codes by number of eviction filings, eviction filing rate, and percent of families in poverty, respectively. Table 4 provides the values and ranks for each of the indicators as well as the combined rank score for the zip codes with the 20 lowest combined scores, i.e., the greatest combined need/uptake potential.
