The Wolstenholme twin mansion at 330 Upsal Street/580 Pelham Road is under threat of demolition. Built by Drexel & Company/Wendell & Smith for the Pelham development in the Mount Airy section of Philadelphia, it features a terra cotta medallion at the center of the Flemish gable depicting two angels blowing trumpets. First occupied by the Wolstenholme brothers, heirs to a textile fortune, in the late 1890s.

Pelham is perhaps the most intact "Arts and Crafts" movement neighborhood in the United States. Its developers wanted to emulate the philosophy of the English philosopher John Ruskin. All of its homes were built by prominent architects: Horace Trumbauer, Boyd & Boyd, William Lightfoot Price, and Chester Kirk.

The loss of this home would be a blow to the integrity of a neighborhood whose craftsmanship and careful layout cannot be replicated today. It is vitally important that Philadelphia protect its architectural history, which is so rich and beautiful. Please let's NOT knock down another gorgeous piece of our history to make way for something cheap and ugly. There are empty parcels, and lots with uninteresting and decrepit properties, that can be cleared for development. Let's not permit the destruction of our important and interesting architectural heritage.

To the Philadelphia Historical Commission:

As residents of the Pelham neighborhood of West Mount Airy and as professionals in the architecture and preservation fields, we write to strongly support designation of the Wolstenholme Twin (580 Pelham Road / 333 W. Upsal Street) to the Philadelphia Register of Historic Places.

Constructed in 1894 as designed by Boyd & Boyd, the Wolstenholme Twin is an outstanding example of late 19th-century Flemish Revival residential design in West Mount Airy. Its Pompeian brick, carefully articulated massing, and ornate architectural detailing exemplify the high-quality materials and craftsmanship found throughout the Pelham development. This building has served for more than 130 years as a distinctive neighborhood landmark and gateway at the southern edge of Pelham. Its form and siting define views and pedestrian experience at the intersection of Pelham and Upsal, anchoring one end of a remarkably intact historic district.

The Wolstenholme Twin contributes materially to the character and cohesion of the Pelham development. Pelham is one of Philadelphia's most completely preserved historic neighborhoods, and this property is fundamental to the district's continuity, character, and sense of place. The exterior retains a high degree of integrity; its character defining features convey the building's original design, construction methods, and architectural intent.

The property's potential demolition or irreversible alteration would cause immediate and lasting harm to the streetscapes of Pelham Road and Upsal Street, as well as to the Pelham district's overall historic fabric. Designation would protect an exceptional example of Boyd & Boyd's work, preserve neighborhood character, and ensure that future changes occur through a public, reviewable process that balances preservation with responsible stewardship.

In summary, considering the architectural distinction, high degree of exterior integrity, and central role in defining Pelham's historic streetscape, the Wolstenholme Twin clearly meets the criteria for listing on the Philadelphia Register of Historic Places. We urge the Commission to approve designation to safeguard this irreplaceable neighborhood landmark.

To the Philadelphia Historical Commission:

As a resident of Pelham and a professional historian, I strongly urge the Philadelphia Historical Commission to designate the property at 333 West Upsal Street / 580 Pelham Road for preservation. Rather than demolish this striking visual anchor of the Pelham neighborhood, new or prospective owners should consider some form of multi-family adaptive reuse. The potential loss of this house has created grave concerns among many of the residents.

The Pelham section of West Mount Airy is one of the most intact Arts and Crafts residential developments in the United States. Conceived by the developers Wendell & Smith in the early 1890s, it remains a remarkably cohesive and vibrant neighborhood to this day. The district includes works by some of the most significant architects of the era, including Horace Trumbauer, designer of Lynnewood Hall and Harvard University's Widener Library; Chester Kirk, architect of the Baltusrol Golf Club clubhouse in New Jersey; and William Lightfoot Price, designer of Woodmont in Gladwyne and the Hedgerow Theatre in Rose Valley. The development itself was deeply influenced by the ideals of the British philosopher and social critic John Ruskin, emphasizing craftsmanship, beauty, and harmony between architecture and landscape.

The property in question, designed by the architectural firm Boyd & Boyd, is an especially important part of this architectural ensemble. Boyd & Boyd designed numerous distinguished residences in Mount Airy, Wayne, and Overbrook, and this house stands as one of their most prominent surviving works. Constructed in 1894 as a dramatic visual landmark for passengers arriving at the nearby Upsal Station, the house is a striking Flemish Revival twin mansion built of buff Pompeian brick. Its architectural features include elaborate Flemish gables and a terra-cotta medallion bearing the date "1894," ornamented with two angels blowing trumpets. The house was originally occupied by brothers Robert and Fred Wolstenholme, sons of Frederick Wolstenholme, proprietor of the Allegheny Worsted Mills in Frankford. Clearly, this house was built to last the ages, unlike so much modern residential construction.

The loss of this building would represent a serious blow to the architectural integrity of the Pelham neighborhood, whose residents are actively discussing broader historic designation. Pelham is currently under substantial development pressure, including proposals to subdivide lots and demolish historic homes that could not realistically be replicated under present economic

conditions. This house serves as a major architectural anchor within the neighborhood, and its demolition would send a troubling signal that other historic properties are similarly vulnerable.

Designation of 333 West Upsal Street / 580 Pelham Road would affirm that the City of Philadelphia recognizes the historic and architectural importance of Pelham and values its preservation for future generations.

I strongly suggest that the developers work with the community on how the exterior of the building can be preserved while the rest of the property can be used for multi-family housing.
