

PHILADELPHIA PARKS & RECREATION OUTDOOR SOCCER LEAGUE BYLAWS 2026-2027

MISSION STATEMENT

It is the goal of the Parks & Recreation Outdoor Soccer League to provide an enjoyable, safe and physically beneficial activity for the youth of Philadelphia. Learning and development of skills, appreciation of the game and constructive competition are emphasized. The time frame for the league is the fall with play beginning the weekend after Labor Day and culminating before Christmas. Those teams wishing to continue their soccer experience may do so with the Parks & Recreation Indoor Soccer League, which begins play in January.

FORMATION:

- A. Affiliation: The Philadelphia Parks & Recreation (PPR) Soccer League is affiliated with the Eastern Pennsylvania Youth Soccer Association (EPYSA), the United States Youth Soccer Association (USYSA), and the Federation International de Football Association (FIFA).
- B. Administration: The PPR is administered by the Outdoor Soccer Committee under the Sports and Athletics Section of the Parks & Recreation. The committee is comprised of the City Chairperson and all the league directors. The City Chairperson will also act as league registrar with EPYSA.
- C. Advisory Council: The Philadelphia Soccer Advisory Council, comprised of volunteers from the soccer community, assists in the administration of the league by serving on grievance committees and advising in the administration and direction of the league.

LEAGUES

- A. The following leagues will be offered for males and females based on number of teams registered for the 2026-2027 season:

- B. Teams apply for skill level (A or B). The League Director will determine placement if there is a need for more than one division. Commitment form means acceptance of placement.

ELIGIBILITY REQUIREMENTS:

- A. Each soccer club must register with EPYSA by July 1st going online and completing the RG1.
- B. All players and coaches must be registered with the league in accordance with the registration procedure.
- C. Adults seeking to coach a team must complete a Risk Management form online through EPYSA's website, as well as take a concussion course with certification held by their club. Failure to do so will cause loss of coaching privileges.
- D. All Coaches/Board Members/Volunteers associated with a Club **MUST** have PA Criminal Record and Child Abuse Clearances on file with their club (if they have not lived in the State of PA for the last 10 years, they must also provide FBI fingerprint screening
- E. Players may play on only one team and in only one age division. Penalty will be loss of all games involving that player and disciplinary action taken against the player and/or coach.
- F. For teams to be eligible to participate in City Playoffs, teams must represent a group or organization within the City of Philadelphia. Teams based in the city still **MUST** maintain a roster with a MAJORITY (greater than 50%) of players being residents of Philadelphia.
- G. Teams/organizations based outside of Philadelphia are eligible to participate. However, the team is not eligible to participate in the playoffs and must play all games (home or away) within the City of Philadelphia limits.
- H. Ages – will be based on Birth Year (See chart in section II. A). Players are permitted to play-up two age groups. Example: a U8 player may play U9 or U10 but may not play on a U11 team or higher.
- I. Use of an ineligible player will cause a team to forfeit all games played using that player. Playing under an assumed name, falsifying rosters or giving false information to league directors will constitute a commission of fraud. The penalty to the player and/or coach for such a commission of fraud will be a minimum one (1) year suspension from the Outdoor Soccer Program.

REGISTRATION

A. Club/Organization Meeting will take place for Club Directors at 7:00pm on Wednesday, June 3, 2026, at American Legion Playground. All Club commitment forms; compliance forms and payments are due currently. Each club is mandated to send their director or club representative. Clubs not represented may be ineligible to participate.

Team Commitment Form, Roster and Assignor Fees are due on these dates.
Teams registering after June 29th, are not guaranteed a spot in the league.

ALL LEAGUE FEES MUST BE PAID IN FULL PRIOR TO THE FIRST GAME. IF YOUR CLUB/TEAM IS NOT PAID THE TEAM WILL BE UNABLE TO PLAY UNTIL FEES ARE PAID AND WILL RECEIVE A FORFEIT.

B. When registering as a primary team the coach must submit a completed roster downloaded from GotSport. **Pictures in GotSport MUST be passport type photos. Headshot only! No baseball caps or hats.** (If another league accepts a picture in GotSport, PPR still has the right to decline the picture.) Proof of birth may be state or hospital birth certificate, passport or alien registration card. In addition, official government documents with birth date and ID number will be accepted. Letters from parents, relatives, school officials, etc. will not be accepted.

C. **Secondary players are permitted. (Maximum of 5 Secondary Players).**

When registering a secondary team, the coach need only hand in three duplicated copies of the team's official stamped primary roster. Also, have the primary league give PPR Soccer the ability to "view" your roster. This is done by contacting the EPYSA Registrar.

D. It is the coaches' full responsibility to register only players who meet the proper age requirements. Listing an overage player (even if not detected by league officials) is still a cause for forfeiture of games.

E. Maximum number of players per team is:

U8, U9 and U10 = 12 Players

U11 & U12 = 16 Players

U13 & U14 = 18 Players

F. All rosters are frozen, for the duration of the season prior to the third "regularly" scheduled game.

G. All league fees must be paid when commitment forms are handed in.

H. League fees are as follows:

U8, U9 and U10 = \$475.00 plus \$30 Assignor's Fee (Venmo: Gordon-Dunlop)

U11 & U12 = \$500.00 plus \$30 Assignor's Fee (Venmo: Gordon-Dunlop)

U13 & U14 = \$525.00 plus \$30 Assignor's Fee (Venmo: Gordon-Dunlop)

I. **Club Pass Players. Teams are allowed Club Pass Players from their Club ONLY.**

U8, U9, U10 – No more than 3 Club Pass Players per game.

U11, U12, U13, U14 and U15– No more than 4 Club Pass Players per game.

NO CLUB PASS PLAYERS MAY BE USED AT ANY TIME DURING THE PLAYOFFS.

Club Pass players must be on the game day roster through GotSport OR written in with both coaches initials next to name.. Club pass player must wear same uniform as the team and there may be no duplicated jersey numbers.

J. Secondary teams are permitted but rosters must be identical to that of their primary league. Secondary Team Fee is \$300.00 plus \$30 Assignor's Fee (Venmo: Gordon-Dunlop). (All age groups)

K. A player may only register on one primary team that is affiliated with EPYSA. If a player registers on a second primary team without receiving a release from the first team, then he/she is considered ineligible, and games played on the second team will be forfeited.

L. Any player who is residing in another state Association, wishing to play in the EPYSA boundaries, must register and receive approval from his resident state Association. This must be done prior to playing within EPYSA boundaries.

M. Any team that did not register by the final team registration date will have to register on the first player add on night after the season begins. All games scheduled prior to the team registering will be forfeited.

SCHEDULING

A. Each team must submit 1 day per weekend along with a specific time that they are allotted their home field. Please be specific on dates and dates that teams can and cannot play. Do not list as a club. (e.g. Saturday 8:00 – 4:00) Please consider as many Saturday dates as possible. U-8 teams are Saturdays. Each team is also asked to submit two-night individual night anytime throughout the season in which a home game may be played.

B. Teams must submit any specific day, time or dates that they cannot play when they register. If not submitted, this will count towards a rescheduled game. Consider any tournaments that you may be playing in during the season. PPR Soccer will be playing games on October 10th and 11th. (Columbus Day/Indigenous People Weekend).

C. All schedules will be sent to coaches the first week of August 2026.

D. After the schedule is received each team is allowed 3 (three) changes after consulting with the opposing coach and the league director. This must be done prior to August 14, 2026.

E. If a team needs to reschedule a game after the season begins it will be under the discretion of the League Director. There will be a \$50.00 fee to reschedule a game which must be paid prior to the game being officially rescheduled. No team will be permitted to do this more than two times. Rescheduled games must be done 7 days prior to scheduled games during the season or game will result in a forfeit.

RULES

A. This program will be governed by the policies and procedures of the Parks and Recreation Department and the current FIFA rules, except as stated in these bylaws:

B. Players on the field:

U8, U9 and U10 will play 7 v 7

U11 – U12 will play 9 v 9

U13, U14 and U15 will play 11 v 11

C. Length of halves:

U8, U9 and U10 = 25 minutes

Under 11, 12 = 30 minutes

Under 13, 14 = 35 minutes

Under 15 = 40 minutes

D. NO HEADING of the ball U11 and below as described by the US Soccer Mandates

E. Rosters

Rosters **must** be printed out from the EPYSA team page (failure to use official line up forms **WILL** result in forfeiture of games). There will be no exceptions. Each team should present a line-up sheet to the referee and the opposing coach. Forms must list the starting lineup and reserves along with jersey number for each player. If a game is played with a player whose name is not on the form, then that game will be forfeited.

F. All players must have a matching shirt (with number), shorts and socks. Players must wear shin guards and shoes. In the event both teams have the same color jersey, the home team will change shirts.

G. Substitutions: There will be no limit on the number of substitutions.

1. By either team on a goal, goal kick, injury or warning
2. By the team with the ball on a throw in

• **Coaches must bring their player rosters every game.** It is the responsibility of the coaches to check the player's rosters. If a coach chooses to have rosters checked, please advise the referee and he/she will do so. If coaches choose not to check rosters there will be no protests regarding players. If a player is not on the roster, that player may play provided that the player signs the back of the roster sheet in front of the opposing coach. That player's coach **MUST** immediately contact the league director to have confirmation that the information is in GotSport.

H. Home team responsibilities:

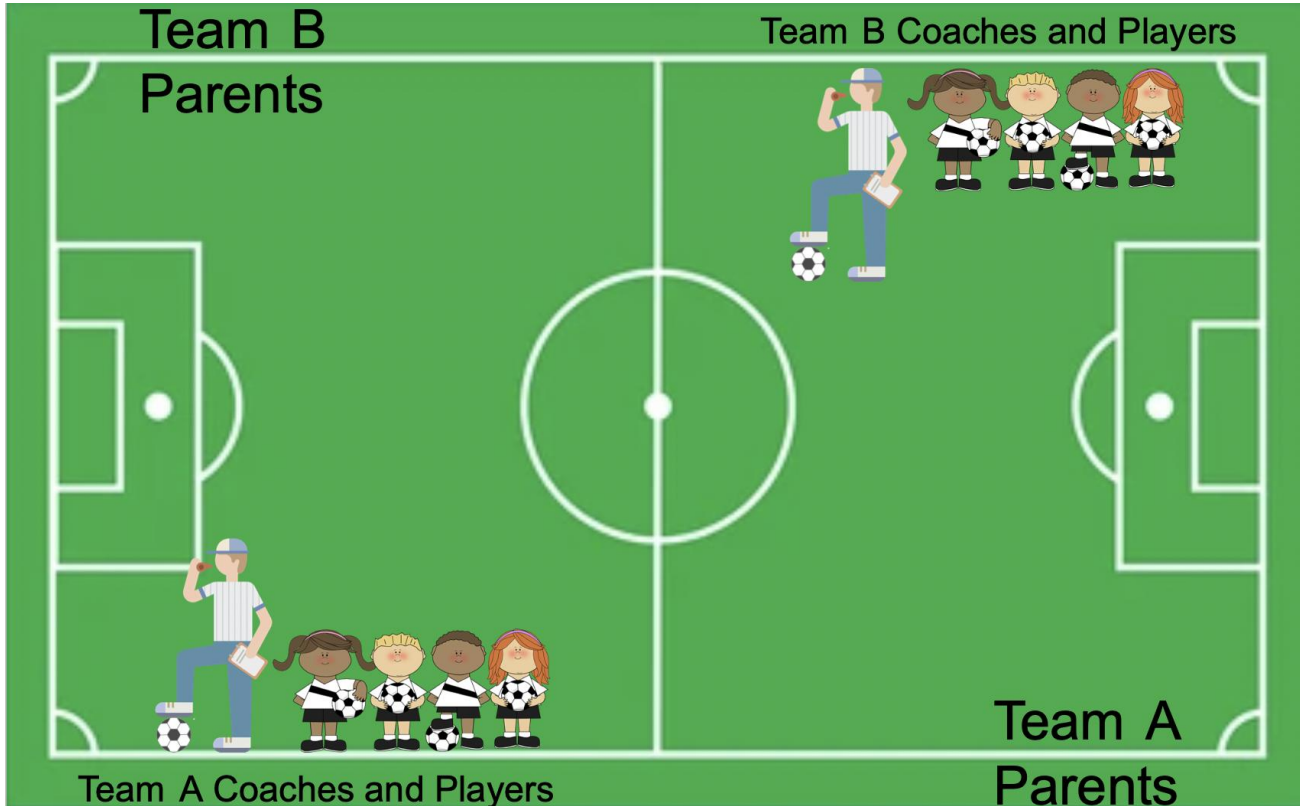
1. Lined fields
2. Goal nets
3. Corner flags (5' minimum)
4. Game ball (U8, U9, U10, U11, and U12 use a #4, Under 13, 14, 15 use a #5)
5. Field and Goal Sizes – Goal sizes differ than EPYSA & USA Soccer guidelines

Players	Field Dimensions	Goal Size
7v7	60 x 45 Max 55 x 40 Min	6x18 Acceptable 7x21 Preferred (especially for U10)
9v9	80 x 50 Max 70 x 45 Min	7x21
11v11	120 x 75 Max 100 x 60 Min	8x24

If the field is not lined or there are no nets, visiting team has the option of having the game forfeited by home team.

If game is played, the outcome will stand. If this situation is repeated, then home team will face disciplinary action.

- I. In the event the referee does not show up for a game, the teams involved have two options:
1. Reschedule the game. (Recommended)
 2. Play the game with a substitute referee that is agreed upon by both teams. No protest will be accepted if this option is chosen.
 3. In event that a referee does not show to any Playoff Game the game MUST be rescheduled through the League Director. There are not exceptions to this rule.
- J. Location of Spectators:
1. **All spectators are to be located on the same side of the field with the players and coaches. They must also be 10' (Ten Feet) back from the sideline. Spectators will face the opposing team from across the field. THIS WILL BE ENFORCED BY PPR AND OFFICIALS DURING 2026 – 2027 SEASON.**



GRIEVANCE BOARD

- A. In the event of a protest, appeal or disciplinary action, the league will convene with the Grievance Board.
- B. This board will be under the direction of the City Soccer Chairperson and will consist of members of the Soccer Advisory Council, league directors and members of the soccer community.

FORFEITS

- A. A team has 15 minutes from the official starting time to field a minimum of 7 players. Teams not doing so will forfeit the game.
- B. In the event of a forfeit, the referee **is not to be paid on the field**. The referee will be paid by the forfeiting team prior to their next game. The fee must be paid electronically to the assignor via Venmo: Gordon-Dunlop. Team not forfeiting game must call in the forfeit to the league director.
- C. Two forfeits will automatically drop a team from the league.

PROTESTS

- A. Protests will be accepted and considered on matters of rule interpretation and eligibility only. A referee's judgment cannot be protested.
- B. Rule Interpretation
 - 1. The protestor must notify the referee at the point of protest (or at the immediate conclusion of the half in which incident occurs) and note that a protest has been lodged on the line up sheet with the time in game and score at the time noted. The protestor **MUST SIGN** the line up sheet. Extenuating circumstances accepted.
 - 2. If point #1 is followed properly then a formal protest may and must be submitted in writing (with evidence to support the protest) to the league director within **48 hours** along with a \$50.00 fee. Failure to comply either point #1 or point #2 will result in **NO PROTEST**.
 - 3. For protest to be accepted, the following two stipulations must be met:
 - a. The ruling protested had a direct effect on the outcome of the game.
 - b. One team was given a decided advantage over the other.
 - 4. If the protest is upheld, the game will be replayed and the fee returned.
- C. Eligibility can be protested at any time up to the end of the season for a regular season game. For the playoff games, protest must be entered within 24 hours of the game played. It is the duty of the protestor to prove the ineligibility of the player in question. Submit the protest in writing along with the \$50.00 fee to the City Chairperson.
- D. The protest will be reviewed by the City Chairperson, who may or may not convene a protest board to hear the case, may rule on the protest, or may reject the protest due to the above clauses. If a hearing is held, all parties involved will be invited to attend. The City Chairperson has the discretion to limit the number of attendees from each party. Attorneys and recording devices are prohibited.
- E. If the protest is upheld, all fees are returned.
- F. For any protests denied there is the right of appeal to the Eastern Pennsylvania Youth Soccer Association Arbitration Board.

CONDUCT

A. Good conduct by all players, coaches and spectators is mandatory before, during and after all games.

C. Each team is responsible for the conduct of its fans (PLEASE NOTE – Spectators that are removed from the field may result in suspension/discipline towards the Coach and/or Club)

D. Any player receiving a red card or coach/assistant coach/spectator who has been removed from the game by the referee will be given a minimum one (1) game suspension, which cannot be appealed. Removed/suspended coach/assistant coach/spectator/player will not be permitted within two hundred (200) yards of field of play, in all directions. Failure to comply will result in further disciplinary action. Second offenses and conduct of a more serious nature will be dealt with by the Soccer Chairperson and Sports and Athletics Coordinator.

E. **If a player is red carded or any coach/spectator removed from the field, his/her coach MUST immediately email the league director and chairperson and report the ejection. The City Chairperson will decide if further action is necessary. The referee will send a detailed report to the City Chairperson. Coaches must notify the league director regarding Yellow Cards as well. Failure to inform league director of carded players will result in the coach being suspended – length TBD.**

F. Suspensions for Misconduct Toward Game Officials

If serious injuries are inflicted to a game official due to an assault the **minimum suspension** will be at least five (5) years. The incident will be reported to authorities.

1. Deliberately striking or kicking or attempting to kick, throwing a soccer ball or other object at, or spitting on a referee or assistant referee: **1st offense = 1 to 2 years 2nd offense = 3 to 5 years.**

2. Any verbal threat of bodily harm or threat of property damage towards a referee or assistant referee: **1st offense = 3 games, 2nd offense = 1 year minimum**

3. Gesturing or signaling obscenely at a referee or assistant referee: **1st offense = 3 games 2nd offense = 5 game minimum**

4. Abusive language directed at a referee or assistant referee:
1st offense = 3 games 2nd offense = 5 game minimum

5. Dissent: **1st offense = TBD 2nd offense = TBD**

G. Suspension of Misconduct Toward an Opponent, Colleague or Spectator

1. Fighting (i.e. engaging in combat with an opponent, colleague or spectators by means of mutual exchange of blows delivered by hand, head, foot or other portions of the body)

Suspended for 1 year minimum

2. Deliberately attempting to strike or kick an opponent, colleague or spectator:
1st offense = 3 games 2nd offense = suspended for 1 year minimum

3. The verbal threat of bodily harm or property, gesturing or signaling obscenely, the throwing of objects: (soccer ball, snow, ice balls, stones, rocks dirt mud, etc.) at an opponent, colleague, or spectator

1st offense = 3 game minimum 2nd offense = suspended for 1 year minimum

H. Suspensions for serious Foul Play and Persistent Misconduct

1. Serious foul play shall be understood to be played characterized by fouls, as defined by Law XII of the Laws of the Game of an aggravated nature committed with such fervor as to threaten an opponent with serious physical harm:

1st offense = 2 games

2nd offense = 4 games

2. Suspension for abusive language directed at an opponent, colleague or spectator:

1st offense = 1 game

2nd offense = 3 games

3. Persistent misconduct (i.e. ungentlemanly conduct, persistent infringement of the Laws of the Game, unauthorized entry onto the field of play, etc.)

1st offense = 1 game

2nd offense = 3 games

4. Dissent:

1st offense = 1 game

2nd offense = 3 games

The above suspensions are to be considered minimum. The league reserves the right to increase these suspensions based on the seriousness of the violation. The Soccer Committee will deal with situations not listed on an individual basis.

I. Conduct Detrimental to the Good and Welfare of Soccer

Any player, team official, club officer or spectator whose conduct is considered to be detrimental to the good and welfare of soccer shall be suspended a minimum of one (1) game for the first offense and for a minimum of three (3) games for the second offense or more within a two (2) year period. Such misconduct shall include but shall not be limited to misbehavior while a spectator, the consumption of alcoholic beverages and/or the use of illegal substance in the vicinity of the playing field before, during or after the soccer game.

J. Suspension is not necessarily reciprocal with other leagues (but WILL be recognized by all PPR Soccer Leagues). Players/coaches suspended in PPR will not play in the next PPR game(s). An exception would be actions of grievous nature such as attacking a referee. These will be dealt with on an individual basis.

K. Philadelphia Parks & Recreation will suspend FROM ALL DEPARTMENTAL ATHLETIC ACTIVITY, for a **MINIMUM** period of FIVE (5) years, anyone who, in relation to an athletic event:

1. Physically assaults a departmental employee or a member of his/her family.
2. Physically assaults a referee or member of his/her family.
3. Physically assaults a Parks & Recreation volunteer or member of his/her family.
4. Or otherwise causes damage to the property or personal possessions of the people.

L. Cautions (yellow card) will be accumulated during the season. Upon receiving his/her **SECOND CAUTION**, said player will receive an **ONE (1)** game suspension (not

appealable). Receiving a **FOURTH** yellow card will result in a **THREE (3)** game suspension (Not appealable) and may be subject to further disciplinary action.

M. If a player has less than **TWO (2)** Yellow cards during the Season – Cautions will be reset for the Playoffs.

N. Appeals of disciplinary actions (other than the mandatory one game suspension) may be made to the Grievance Committee by handing in a written appeal within **48 hours** along with a \$50.00 appeal fee.

O. If a game is abandoned by the referee due to conduct the referee will send a game report to the league. The league will then decide the course of action.

GENERAL INFORMATION

A. The following point values will determine standings in the regular season:

WIN = Three (3) points

TIE = One (1) point

LOSS= Zero (0) points

B. For teams tied in the standings at the end of regular season, the following procedure will apply:

1. A game will be played to break a tie for:

- a. The last playoff spot
- b. A position receiving awards
- c. A bye at the playoffs

2. If there is a three-way tie for one of the situations above, the following system will be used:

- a. Teams will be drawn by lot (1, #2, #3)
- b. Team #1 will play team #2
- c. The winner will play team #3 with this winner becoming the tiebreaker winner

3. All other ties will be decided in the following order:

- a. Head-to-head record (total goals do not apply)
- b. Coin flip

C. Referees for playoff games will be as follows:

1. Semifinals: one referee will be assigned but league has the discretion to assign three referees if needed.

2. Championship games: the three-referee system **may** be used. The cost will be divided evenly between the two teams (both teams must agree) – League can mandate if deemed necessary

D. Semifinals and Championship games will be determined by the PPR Soccer before the season begins. This information will be provided on the league schedule. Playoff and Championships games will be played at a site determined by the City Chairperson prior to the beginning of the season.

Semifinal Games – Saturday November 8th and Sunday, November 9th.

Championship Games – Saturday, November 15th and Sunday, November 16th

E. For tie breaker games or playoff games there will be no ties. If tied at the end of regulation time, two (2) overtime periods will be played sudden death (1st team to score) as follows:

U8, U9, U10, U11 and U12 = two (2) five-minute halves

U13, U14 and U15 = two (2) ten-minute halves

If still tied the match will be determined by penalty kicks.

F. The winning team must call or email the score to the league director within 24 hours. In case of a tie, the home team calls.

G. To make up a postponed game, coaches must get together and agree on a date within **ONE WEEK** of the original game and then call the league director for a referee. If **not** done within this time frame, the league director will schedule the game.

H. Because of the complexity of scheduling, equal home and away games cannot be guaranteed. Every effort will be made to keep the schedule as equitable as possible.

I. The PPR All Star Games will take place during the evening on Thanksgiving Eve. League Directors will provide more information regarding players/dates/times.

J. All other incidents not covered in these rules will be decided by the Outdoor Soccer Chairperson and the Sports and Athletic Coordinator whose decision is final.

REFEREE FEES

U10, U9 and U8 = \$50 (\$25.00 per team)

U11& U12= \$60 (\$30 per team)

U 13, U14 = \$162 (\$81 per team) 3 Referee System will be used when possible. \$72 (\$36 per team) when there is one referee.

U15 = \$184 (\$92 per team) 3 Referee System will be used for every game.
