Agenda Item #1 - Approval of the Minutes of October 27th, 2016

Mr. Dubow requested approval of the Minutes for October 27th, 2016. Mr. Stagliano made the motion. Mr. Rodriguez seconded. The motion passed.

Agenda Item #2 - EIV Fund III

Michelle Davidson and Matthew Coyne of TorreyCove presented the reports. Patricia Melcher and David Finan of EIV Capital made their presentation to the Board.

Mr. Dubow asked how involved they are in the investments.

Ms. Melcher answered they are very active in the investments and that they make between 8-12 investments per fund.

Mr. Dubow requested a motion to approve a \$30 million investment in EIV Capital Fund III. Mr. Rubin made the motion. Mr. Coughlin seconded. The motion passed.

Agenda Item #3 - UBS Trumbull Property Fund

Mr. Obed of Marquette presented the memo on Core Real Estate and UBS Realty. UBS was selected from other funds which included: J.P Morgan, Morgan Stanley, and PRISA. Maria Bagetta and Kevin Crean of UBS made their presentation to the Board.

Mr. Dubow requested a motion to approve Staff's and Marquette's recommendation to allocate \$75 million to UBS. Ms. Stukes-Baylor made the motion. Mr. Stagliano seconded. The motion passed.

Agenda Item #4 - Lyrical Antheus Co-Investment

Mr. Obed introduced the report on Lyrical Capital. Eli Ungar of Lyrical-Antheus presented to the Board.

Mr. Dubow requested a motion to approve a \$2.5 million co-investment recommendation with Lyrical-Antheus. Mr. Stagliano made the motion. Ms. Stukes-Baylor seconded. The motion passed.

Agenda Item #5 - Mid and Small Cap Equity Active Manager Recommendations

Mr. Obed made the presentation. Mr. Obed said an objective, in addition to overall performance, is to keep fees low and competitive therefore, performance and fees were closely examined.

Mr. Obed pointed out the performance of mid-cap manager Ceredex has lagged the benchmark and since they cannot outperform, Staff and Marquette recommends termination.

Mr. Obed also recommended Hahn for termination for high deviation from the benchmark.

Mr. Obed said within the small cap composite, Emerald and Fisher, have outperformed and therefore no action should be taken. Mr. Obed added that Staff is looking to liquidate the Rhumbline Russell 2000 Index Fund and phase it into the Russell 2000 Core Fund.

Mr. Rubin asked why the money could not be placed with the managers that are outperforming the benchmark.

Mr. Obed answered it is good to have a balance of passive and active managers since there can be periods when active managers will not perform as well.

Mr. Dubow requested a motion to approve the termination of Ceredex and Hahn and to place the proceeds into the Rhumbline Mid Cap Index, and to transition the Rhumbline Russel 2000 Growth Index fund to Rhumbline Russel 2000 Core Index fund. Mr. Stagliano made the motion. Mr. Rodriguez seconded. The motion passed.

Agenda Item #6 - Core Fixed Income Allocation Recommendation

Mr. Obed presented the reports. Mr. Obed stated that the proceeds from the termination of a manager in August 2016 was \$106 million. Staff along with Marquette recommends that the assets be placed into two active managers in Core and Core Plus Domestic Fixed Income.

Mr. Obed stated that Garcia Hamilton has about 2.6% of the portfolio, Logan Circle has 1%, Longfellow has 2.3% and Rhumbline has 6.4%.

Mr. Obed noted that it is not uncommon for plans of this size to have some exposure to passive fixed income as a way to reduce tracking error and keep fees low.

Mr. Dubow requested a motion to approve Staff and Marquette's recommendation that the \$106 million, from the termination of Allianz that was transferred to the Rhumbline index fund, be reallocated between Garcia Hamilton & Associates and Longfellow Investment Management Co. Ms. Stukes-Baylor made the motion. Mr. Rodriguez seconded. The motion passed.

Agenda Item #7 - Flash Report for Period Ended October 2016

Mr. David Smith presented the flash report.

Mr. Dubow asked for any questions. There were none.
