#### Case of Nadine Ector, Application for Service-Connected Disability Benefits - Plan B

This is an application submitted by Nadine Ector, former Police Officer for Service-Connected Disability benefits under Pension Plan "B".

According to Ms. Ector, on April 20, 2015 she slipped on an unknown liquid, hyper-extending her knee causing injuries to her knee and hand.

# Case of Monaie Pistoria, Application for Service-Connected Disability Benefits - Plan B

This is an application submitted by Monaie Pistoria, former Police Officer for Service-Connected Disability benefits under Pension Plan "B".

According to Ms. Pistoria, on April 17, 1997 while in training at the Police Academy she sustained an injury to her knee. Ms. Pistoria further states that on October 6, 2015 while responding to a vehicular accident she slipped on motor oil and twisted her knee.

# Case of Kendall Robinson, Application for Service-Connected Disability Benefits - Plan B

According to Mr. Robinson, on August 25, 2015 while attempting to remove a prisoner from a cell he was physically assaulted and sustained multiple injuries.

According to Mr. Sweeney, on May 26, 2012 while on bicycle patrol he struck the curb snapping his head forward then back which caused him to sustain multiple injuries.

# Case of Elbert Fields, Application for Service-Connected Disability Benefits - Plan Y

This is an application submitted by Elbert Fields, former Automotive Maintenance Technician with the Department of Fleet Management for Service-Connected Disability benefits under Pension Plan "Y".

According to Mr. Fields, on March 15, 2010 while removing tires from a vehicle in order to check the brakes he injured his back.

### Case of Victoria Smith, Application for Service-Connected Disability Benefits - Plan Y

This is an application submitted by Victoria Smith, former Custodial Worker with the Department of Human Services for Service-Connected Disability benefits under Pension Plan Y.

According to Ms. Smith, on May 19, 2014 as she was lifting freshly laundered (clean) clothing out of a laundry bin she sustained a shoulder injury.

It is reported that Mr. Glenn sustained a hip injury on or about July 31, 2014. It is further reported that Mr. Glenn was sweeping trash and sludge on October 12, 2016 when he felt pain in his knee and hip.

# Case of Ernest J. Colwell, Deceased, Application for Survivorship Benefits Option 4-Plan D

This is an application by Geraldine Colwell, as ex-spouse for survivorship benefits in Plan D.

Ernest J. Colwell, former Police Officer died February 4, 2018.

Mr. Colwell retired effective April 6, 1986. On April 7, 1986 Mr. Colwell signed his retirement papers. He elected Option #4 naming Geraldine Colwell, spouse as his survivor.

On February 7, 2018, Geraldine Colwell reported the death of Ernest Colwell to the Board of Pensions. On February 26, 2018 a survivorship application was sent to Geraldine Colwell.

On July 30, 2018 Mrs. Colwell submitted the survivorship application, a copy of her marriage certificate to Ernest J. Colwell dated June 11, 1958 and her divorce from Ernest J. Colwell dated April 19, 2005.

On August 1, 2018, a letter from the Board of Pensions was sent to Mrs. Colwell stating her application for survivorship benefits under Option 4 was denied.

On August 4, 2018 Mrs. Colwell sent a letter appealing the decision that she did not meet the requirements for survivorship benefits under Option #4.

On August 13, 2018 the Board of Pensions sent Mrs. Colwell an administrative denial letter.

On August 24, 2018 Mrs. Colwell sent a letter appealing the administrative denial.

The Board reviewed the documents submitted from Mrs. Colwell.

#### REQUEST TO RESCIND DROP ENROLLMENT

# Case of Majid Partovi, Request to Rescind DROP enrollment - Plan "J"

This is a request from Majid Partovi, Staff Engineer 2, Free Library, to rescind his DROP enrollment.

Mr. Partovi submitted a DROP application on February 8, 2016 to go into DROP effective pay period ending May 16, 2016. On February 8, 2016 he was sent a letter confirming his DROP enrollment.

On August 1, 2018 the Board of Pensions administratively denied Mr. Partovi's request to rescind his enrollment in DROP. Once accepted into DROP, election to participate is irrevocable.

On August 28, 2018, Mr. Partovi submitted a letter dated August 23, 2018 appealing the administrative denial.

#### REQUEST TO PURCHASE PRIOR CITY SERVICE WITHOUT INTEREST

# Case of Frank Lovett, Request to Purchase Prior City Service without Interest - Plan Y

Effective 9/9/2002 Frank Lovett was dismissed from the Commerce/Aviation department.

On 2/28/2003, Mr. Lovett applied to withdraw his pension contributions. His contributions were refunded on the 3/17/2003 Pension Withdrawal Payroll.

As the result of a settlement agreement, Mr. Lovett was reinstated to his former position effective 9/4/2006. The period from his dismissal until reinstatement was to be treated as a leave of absence. The City made a pension contribution on Mr. Lovett's behalf, so that he received pension credit for the period.

On 10/5/2006, a letter informing Mr. Lovett that he may apply to purchase pension credit for any prior City service was sent to him. The letter stated that to avoid additional interest, his application must have been received by 9/4/2007.

On 11/27/2017, Mr. Lovett applied to purchase pension credit for his period of employment prior to his dismissal.

On 2/23/2018, Mr. Lovett was quoted the cost to purchase pension credit for his prior City service. This quote included the additional past interest, which was referenced in the 10/5/2006 letter.

On 3/16/2018, the Board of Pensions received Mr. Lovett's appeal of the cost of pension credit for his prior City service.

Case Summary:

This is a request by Michael Rodgers, former Water Operations Repair Helper to make application for Service-Connected Disability benefits beyond the one-year deadline under Pension Plan Y.

Michael Rodgers separated employment effective January 4, 2016.

On May 15, 2018 Mr. Rodgers submitted a letter requesting to make application for a Service-Connected Disability beyond the one-year deadline.

Case Summary:

Kenneth Gassman, a former inspector with Licenses & Inspections, was first hired through the Water Department on July 11, 1994, transferred to L&I on August 25, 1997, and separated from City employment on August 23, 2010. He pleaded guilty to one count of extortion under the Hobbs Act, 18 U.S.C. § 1951. At the time of his separation, he had approximately 15 years, 10 months, and 19 days of credited service. At age 60 he would be entitled to \$1,795.00 per month and has \$15,748.90 in the system.

On February 12, 2018, Ellen Berkowitz, Senior Attorney, opined that Mr. Gassman's crime triggered the disqualification provisions of the Public Employees' Pension Forfeiture Act and the Philadelphia Retirement Code and that through his criminal conduct he had severed his entitlement to his pension. He currently owes \$5,075.00 in fines and restitution in Federal court.

Ms. Berkowitz advises the Board must vote on the following:

- Whether Mr. Gassman should be permanently disqualified from pension eligibility
- Whether his contributions should be held in part to pay his outstanding fines and restitution.

Sharolyn Murphy made a motion to deny the appeal of the pension disqualification. Carol Stukes-Baylor seconded the motion.

The motion to deny the appeal of Kenneth Gassman's pension disqualification carried unanimously 8-0.

#### **NEW BUSINESS**

- Executive Director's Report Mr. Bielli stated that training on the One Philly program will begin the second week of October, 2018.
- Medical Panel Subcommittee Mr. Rubin stated that the Medical Panel Subcommittee met on April 26, 2018 and issued an RFP for Independent Medical Examination services. An RFP was initiated, and staff received and reviewed a number of responses. The subcommittee recommended keeping Dr. Weinerman as well as Eastern Orthopedics Associates. In addition, the panel recommended contracting with Rothman Institute, Juris Solutions, Inc. and the Medical Consultant Network. Mr. Rubin thanked committee members Ms. Dunn, Ms. Stukes-Baylor and Mr. White for their participation.

The motion to approve Dr. Brent Weinerman, Eastern PA Orthopedic Associates, Rothman Institute, Juris Solutions, Inc. and the Medical Consultant Network for the 2018 Medical Panel carried unanimously 8-0.

Service-Connected Disability Reexamination
