#### Case of Michael Brooks, Application for Service-Connected Disability Benefits - Plan "B"

This is an application submitted by Michael Brooks former Police Officer for Service-Connected Disability benefits under Pension Plan "B".

According to Mr. Brooks, on March 16, 2017 he slipped and fell onto the ice causing his injury.

# Case of Denise Dixon, Application for Service-Connected Disability Benefit - Plan "B"

This is an application submitted by Denise Dixon, former Police Officer for Service-Connected Disability benefits under Pension Plan "B".

According to Ms. Dixon, on June 6, 2011 while serving at a "flash mob" detail, she fell over a hump in the sidewalk. Ms. Dixon further states that she impacted the sidewalk with her knees and braced hands, and she also sustained an injury to her back.

Sharolyn Murphy made a motion to deny. Christopher Rupe seconded the motion.

The motion to deny carried 3-0-4.

# Case of Andria Hooks, Application for Service-Connected Disability Benefits - Plan "B"

This is an application submitted by Andria Hooks, former Police Officer for Service-Connected Disability benefits under Pension Plan "B".

According to Ms. Hooks, on April 23, 2016 while working a traffic post she backed up, caught her left leg and tripped over an uneven manhole covering causing injuries to her ankle and foot.

Ronald Stagliano made a motion to approve. Brian Coughlin seconded the motion.

The motion to approve carried unanimously 7-0.

#### Case of Eugene A. Kittles, Application for Service-Connected Disability - Plan B

This is an application submitted by Eugene Kittles former Police Officer for Service-Connected Disability benefits under Pension Plan "B".

According to Mr. Kittles, on August 12, 2015 while serving a search and seizure warrant on a dimly lit garage he stepped onto an undisclosed item and severely twisted his left knee.

Sharolyn Murphy made a motion to deny. Christopher Rupe seconded the motion. The motion failed 2-5.

# Case of Francis Rogalski, Application for Service-Connected Disability Benefits - Plan B

This is an application submitted by Francis Rogalski, former Police Officer for Service-Connected Disability benefits under Pension Plan "B".

According to Mr. Rogalski, on August 4, 2014 after checking the availability of vehicles on the police lot he was returning to the interior of the District when he tripped over a broken step and fell. Mr. Rogalski states that during the fall he sustained multiple injuries.

Ronald Stagliano made a motion to approve. Brian Coughlin seconded the motion.

The motion to approve carried unanimously 7-0.

#### Case of Sharona L. Vassell, Application for Service-Connected Disability Benefits - Plan B

This is an application submitted by Sharona Vassell, former Police Officer for Service-Connected Disability benefits under Pension Plan "B".

According to Ms. Vassell, on August 11, 2013 while in foot pursuit of a male robbery suspect with a gun, she twisted her ankle. Ms. Vassell states that she lost sight of the suspect but continued to search, climbing a fence to check the alley and another fence to check the rear of a stretch of homes. She observed the suspect in the basement of a home. She indicates that she kicked the basement door and the suspect fled upstairs only to return to the basement when he discovered the locked door; he resisted arrest and a struggle and altercation ensued. Ms. Vassell states that after the suspect was subdued and she had returned to her vehicle it was then that she felt pain in her right knee.

Ronald Stagliano made a motion to approve. Carol Stukes-Baylor seconded the motion.

The motion to approve carried 6-1.

#### Case of Michael T. Gainey, Application for Service-Connected Disability Benefits - Plan Y

This is an application submitted by Michael Gainey former Laborer with the Free Library for Service-Connected Disability benefits under Pension Plan "Y".

According to Mr. Gainey, on June 23, 2016 while he was unloading a freight elevator he tore his left rotator cuff.

#### Case of Michael Rodgers, Application for Service-Connected Disability Benefits - Plan Y

This is an application submitted by Michael Rodgers, former Water Operations Repair Helper with the Water Department for Service-Connected Disability benefits under Pension Plan "Y".

According to Mr. Rodgers on July 30, 2015 he accidently cut into his left foot while cutting a pipe.

#### Case of Hyanty Williamson, Application for Service-Connected Disability Benefits – Plan Y

This is an application submitted by Hyanty Williamson, former Custodial Worker with the Commerce Department for Service-Connected Disability benefits under Pension Plan "Y".

According to Ms. Williamson, on November 20, 2016 she slipped in one of the bathrooms she was servicing. Ms. Williamson states that she fell onto the floor injuring her shoulder, hip, wrist, and lower back.

Sharolyn Murphy made a motion to deny. Christopher Rupe seconded the motion. The motion to deny failed 2-5.

Carol Stukes-Baylor made a motion to approve. Veronica Pankey seconded the motion.

The motion to approve carried 5-2.

#### Case of Gary Bonilla, Application for Service-Connected Disability Benefits under B

This is an application submitted by Gary Bonilla, former Police Officer for Service-Connected Disability benefits under Pension Plan "B".

According to Mr. Bonilla on December 11, 2015 while he and his partner were attempting to transport an aggressive patient to another hospital the prisoner resisted by falling to the ground. Mr. Bonilla states that as he began to lift the prisoner from behind he immediately felt pain that radiated from his lower back down his right leg to his foot.

The motion to approve carried unanimously 7-0.
