Case of Jacqueline Morris, Application for Service-Connected Disability Benefits -Plan B

This is an application submitted by Jacqueline Morris, former Police Officer for Service-Connected Disability benefits under Pension Plan B.

According to Ms. Morris, on February 28, 2013, after securing the rear doors of the police wagon, she was entering the passenger side when she lost her footing and slipped. Ms. Morris further states to keep herself from falling to the ground she twisted awkwardly causing an injury.

APPLICATION FOR SURVIVORSHIP BENEFITS ON BEHALF ON A MEDICALLY ADULT DEPENDENT CHILD

Case of Daniel J. Laverty, Deceased, Application for Survivorship Benefits on Behalf of a Medically Dependent Adult Child Plan "X"

This is an application by Christopher J. Laverty, son of Daniel J. Laverty, to receive Survivorship benefits as a medically dependent adult child under Plan X.

Retired Fire Captain Daniel J. Laverty died on April 1, 2017. He retired from the Fire Department effective April 12, 2008.

At the time of his retirement, his wife Kathleen had Power of Attorney for him and choose Survivorship Option 4. His wife, Kathleen Laverty, collected the survivorship benefit from April 2, 2017 until her death on January 15, 2020. Christopher J. Laverty's sister, Lisa A. Laverty is his Power of Attorney.

The Board reviewed the pertinent information and documents submitted.

NEW BUSINESS

Executive Director's Report – Mr. Bielli stated there is still time to register for the PAPERS virtual forum. The NASP 31st Pension Financial Services Conference will be held virtually December 7-10, 2020. Please contact staff if interested in attending the virtual forums.

The Amendment to the Board of Pensions and Retirement Rules was approved by the Ad Board at its meeting on October 9, 2020 making it effective immediately pursuant to Section 8-406 of the Philadelphia Home Rule Charter. The Amendment states that the Board may delay or postpone election of the members who are elected to serve on the Board by the employees in the Civil Service during the existence of a disaster emergency and public health crisis.

Mr. Cousounis explained that the Trustee election takes place every four years and expires November 1st of the 4th year. The last election was 2016. The Governor declared the Public Health emergency is renewed until the end of November. He recommends that meetings are held virtually, and employees' hours should be staggered for the health and safety of workers. For these reasons, the election can not be held in a safe manner.

Trustee Election

Ronald Stagliano made a motion to approve the postponement of the Trustee Election until it can be safely held. Kellan White seconded the motion.

The motion to approve the Postponement of the Trustee Election until it can be safely held carried unanimously 8-0.
