**APPLICATION FOR SERVICE-CONNECTED DEATH BENEFITS**

**Case of Loretta Ann Hill-Gillespie, Dec'd, Application for Service-Connected Death Benefits - Plan Y**

This is an application submitted by Frederick Gillespie Jr., spouse of the late Loretta Hill-Gillespie, former Medical Clerk with the Health Department for Service-Connected Death benefits under Pension Plan "Y".

According to Mr. Gillespie, on May 6, 2020 his wife died. Mr. Gillespie states that his wife was deemed an essential worker, placed on the frontline at Health Center 6, where she checked in persons who were being tested for COVID-19. Mr. Gillespie states that his wife was high risk for the virus. According to Mr. Gillespie his wife was never tested for the virus.

Mr. Gillespie states that during the week preceding her death she was out of work because she was feeling sick. Mrs. Hill-Gillespie died two days following her return to work (May 4, 2020).

Case History:

This is an application submitted by Eileen Carey, former parking enforcement officer with the Philadelphia Parking Authority for Service-Connected Disability benefits under Plan Y.

According to Ms. Carey, on February 16, 2015 she was working in Olde City when she tripped on a low-lying marble step. Ms. Carey states the entire pavement was covered with salt and it was difficult to distinguish the step from the pavement. Ms. Carey sustained multiple injuries.

## **PENSION DISQUALIFICATION**

### **Case of James Strohm– Pension Disqualification, Plan B**

James Strohm, former Philadelphia Police Officer, was first hired on June 23, 1997 and separated from City employment on May 28, 2019. He is a member of Plan B. At the time of his separation, he had approximately 21 years and 10 months of credited service. His estimated monthly pension benefit would be \$3,103.00 per month. His contributions to the Municipal Retirement System total \$65,901.15.

On July 23, 2019, Mr. Strohm entered a plea of guilty to one count of distribution and attempted distribution of child pornography in violation of 18 U.S.C. § 2252(a)(2) and one count of possession of child pornography in violation of 18 U.S.C. § 2252(a)(4) arising out of his possession and dissemination of child pornography in February and April 2019 both at home and while undertaking official duties as a police officer. He was sentenced on January 6, 2021. Mr. Strohm uploaded images from the police station's IP address and kept images on a personal computer stored at the police station. The Inspector General informed the Law Department of the guilty pleas in January 2021.

On February 19, 2021, Sean McGrath, Assistant City Solicitor, opined that Mr. Strohm's crime triggered the disqualification provisions of the Philadelphia Retirement Code and that through his criminal conduct he had therefore severed his entitlement to his pension.

Mr. McGrath advises the Board must vote on the following:

- Whether Mr. Strohm should be permanently disqualified from pension eligibility
