#### Agenda Item #1 - Approval of the Minutes of April 19, 2018 Board Meeting

Ms. Dunn requested approval of the Deferred Compensation Meeting Minutes for April 19, 2018. Mr. Coughlin made the motion to approve the minutes. Mr. Stagliano seconded. The motion carried. Mr. Rupe abstained.

## Agenda Item #2 - Deferred Compensation Plan Update/Activity Report - April 2018

Ms. Cherry advised that Staff will present the second quarter performance update at the August meeting.

Ms. Kumar presented the activity report for the month of April. Total participant accounts were 22,304 of which 79% are actively contributing to the plan. The total plan assets administered by Nationwide were \$1,139,443,416. 401A plan assets totaled \$319,146 at the end of April with 395 participants. There were 29 workshops throughout 19 locations and approximately 457 consultations for the month of April with 234 active enrollments. Ms. Kumar stated that the call volumes have continued to decrease with about 50% of participants using their web accounts.

#### Agenda Item #3 - Nationwide's MIRP Pension Estimator

Mr. Nyce presented a demonstration overview for the 457 Retirement Readiness Tool.

Mr. Rodriguez asked whether the readiness tool automatically calculates pension benefits? Mr. Nyce stated that the tool would provide an estimate of a participant's total retirement outlook and was designed to help participants get on track to retirement readiness.

Ms. Stukes-Baylor asked whether the tool would include any social security income? Mr. Nyce answered that social security can be included in the estimate and demonstrated multiple scenarios and inputs.

Mr. Coughlin complimented Staff and Nationwide on the tool.

Ms. Pankey made a motion to accept the Deferred Compensation tool for participants. Ms. Stukes-Baylor seconded. The motion carried unanimously. (Note: Neither Ms. Rhynhart, Mr. White nor Mr. Rupe were present for this vote.)
