Agenda Item #1 - Approval of the Minutes of June 27, 2019 Board Meeting

Mr. Dubow requested approval of the Deferred Compensation Meeting Minutes for June 27, 2019. Ms. Pankey made the motion to approve the minutes. Ms. Greene-Jones seconded. The motion carried unanimously.

Agenda Item #2 - Deferred Compensation Plan Update/Activity Report - June 2019

Ms. Kumar presented the activity report for the month of June 2019. Total participant accounts were 23,600 of which 18,772 are actively contributing to the plan. The total 457 plan assets administered by Nationwide were over \$1,250,000,000. Ms. Kumar stated the 401A Plan held over \$580,000 with 533 total participants. Ms. Kumar added that there were 281 participants contributing into the ROTH account and 55 participants contributing on percentage basis.

Mr. Nyce described the service and education activity for the month of June: 125 enrollments; 8 new employee orientations, 147 consultations were conducted using the interactive retirement planner; 25 group workshops with 442 attendees; and 429 individual consultations. Mr. Nyce thanked Ms. Greene-Jones and those on the Wellness team who helped set up 2 seminars on ROTH 457 option with a total of 137 attendees.

Mr. Coughlin noted the difference between the 281 participants contributing into the ROTH compared to 55 participants using percentage contribution option. Mr. Coughlin inquired whether Nationwide can provide additional education to the participants on the percentage contribution option. Mr. Nyce stated that their seminars do provide information on the Option but that he will stress to the team to provide further education to the participants about the percentage option and its benefits.

Ms. Greene-Jones stated that she believes the seminars went well. She added that she has received feedback from uniformed and non-uniformed employees following the seminars of their interest and request for more information.

Mr. Dubow asked whether there were any additional questions. There were none.

At 9:48 a.m., Mr. Dubow requested a motion to adjourn the Deferred Compensation Plan Meeting. Mr. Stagliano made the motion. Mr. Coughlin seconded. The motion passed unanimously.
