### Agenda Item #1 – Approval of the Minutes of June 22nd, 2017

### Agenda Item #2 - Rhumbline Infrastructure - Increased Allocation Recommendation

Mr. DiFusco answered the subcommittee is scheduled in August and will be ready to bring a finalist to the Board by September.
