Agenda Item #1 – Approval of the Investment Committee Minutes of September 27, 2018

Mr. Dubow requested approval of the Minutes for September 27, 2018. Mr. Stagliano made the motion. Ms. Pankey seconded. The motion carried unanimously.

Agenda Item #2 –Flash Report for the Period Ending September 2018

Mr. DiFusco introduced Ms. Samantha Grant, who represented Marquette Associates, along with Mr. David Smith. Mr. DiFusco also introduced Mr. Abdel-Aziz Ibrahim to the Board, who was recently hired to join the Staff as an Investment Officer. In addition, Mr. DiFusco introduced Ms. Leontyne Freeman, who is the alternate (Trustee) for Office of Human Resources.
