MINUTES

Case of John W. Crichton, Application for Service-Connected Disability Benefits – Plan B

This is an application submitted by John Crichton, former Police Officer for Service-Connected Disability benefits under Pension Plan "B".

According to Mr. Crichton, on September 27, 2016 while exiting a police vehicle carrying several pieces of equipment, he twisted awkwardly causing an injury.

According to Mr. Evans sometime in 2003 while lifting office furniture from City Hall to a lift gate and then onto a truck he experienced various pains. Mr. Evans further states that sometime

in 2007 while removing a (old) large hot water tank from a fire station for disposal when he felt a "pop" resulting in multiple injuries.

This is an application submitted by Anthony Staszak, former Laborer with the Streets Department for Service-Connected Disability benefits under Pension Plan "Y".

According to Mr. Staszak, on May 9, 2017 while riding on the rear of the recycling truck the driver struck two "potholes" and he fell from the vehicle resulting in multiple injuries.

This is an application submitted by Marc Desiderio, Jr., former Police Officer 1 for Service-Connected Disability benefits under Pension Plan "D".

According to Mr. Desiderio, on October 27, 2006 while working full duty he experienced pain during the night. Mr. Desiderio states that while returning home his left arm went completely numb and he experienced severe pain in his chest.

This is an application submitted by Timothy Crooms, former HVAC Mechanic II with the Department of Public Property for Service-Connected Disability benefits under Plan "Y".

According to Mr. Crooms, on February 9, 2017 while lifting a commercial snow blower to relocate it to another part of the building he suffered an injury.

Case of Marsha Lisby, Application for Service-Connected Disability Benefits - Plan "Y"

This is an application submitted by Marsha Lisby, former Custodial Worker with the Commerce Department for Service-Connected Disability benefits under Pension Plan "Y".

According to Ms. Lisby, on January 4, 2017 she was cleaning and stocking bathrooms in the Airport terminal when she had to go to the stockroom for additional supplies. Ms. Lisby states that as she was reaching up for toilet paper, she immediately felt a "pop" resulting in an injury.

The Board voted as follows:

Case of Robert D. Morrison, Application for Service-Connected Disability Benefits - Plan "Y"

This is an application submitted by Robert Morrison, former Parking Enforcement Officer-Supervisor with the Philadelphia Parking Authority for Service-Connected Disability benefits under Pension Plan "Y".

According to Mr. Morrison, on June 27, 2016 while reading a police regulation sign, he was struck "hard" on the left side of his body. Mr. Morrison states that the force of the impact knocked him face first into the pole, causing multiple injuries.

APPEAL TO CHANGE SURVIVORSHIP OPTION

<u>Case of Deborah Silvetti, Appeal of Administrative Denial to Change Survivorship Option</u> from 3 to 4 – Plan D

This is an appeal of an administrative denial by Deborah Silvetti to change her survivorship option from 3 to 4 in Plan D.

Ms. Silvetti, former Police Officer retired from the Police Department on February 16, 2016. She chose survivorship option 3, naming her grandson Michael Silvetti as her survivor.

In a letter to Francis Bielli, Executive Director dated February 13, 2020, Ms. Silvetti states that Michael has been disabled since March 2002 and receives disability. She was awarded full custody of Michael on June 6, 2002. She further states she was not aware of option 4 when she retired and is requesting now to change her option.

On February 13, 2020, her request to change her option was administratively denied by Administrator Stacey White. On February 24, 2020, Ms. Silvetti appealed the administrative denial.
