Reentry One-Stop Center

Building upon the demand for services by the ex-offender population, The One Stop Center has been designed to provide previously incarcerated individuals with an even broader range of transitional services to help them address the barriers many face as they strive to regain self-sufficiency and secure employment. The goal of the One Stop Center is to reduce recidivism and to increase public safety by offering a comprehensive menu of support to former inmates at one location, under one roof. Proposed services for FY08 include on-site career link accessibility; legal classes/services; child support modification assistance; paternity testing; GED/ABE classes; entrepreneurial seminars; and motivational lectures. While many of the services are accessible on site, other critical resources are made available through a streamlined referral process to outside partners. The support provided by the City's Reentry Partners including: Adult Probation and Parole; Department of Behavioral Health; Office of Supportive Housing; Philadelphia Defender's Association; Faith Based Partners; Philadelphia Prison System and the District Attorney's Office, have contributed to the success of this multi-faceted center.

Curfew Center Initiative

The curfew center initiative is an important Operation Safer Streets program that combines three components of Safer Streets: police activity, intensive social services and community engagement. The goal of curfew centers is to get young people off the streets and "out of harm's way." All of the families of youth picked up for curfew violations are referred to the Department of Human Services (DHS) for preventive services. These services include counseling, parenting training, anti-violence programming, mentoring support, after-school programs, case management, tutoring, mental health and behavioral health.

Residents in curfew center areas have reported noticeable decreases in youth being outside late at night and a quieter community since the centers opened. Police officers commented that their authority has been restored with youth. There has also been an increase in community cohesion as evidenced in the community being empowered to impact youth violence and network amongst each other. The number of minors involved in violent crime in the area dramatically decreased since the inception of the curfew center program.

Philadelphia More Beautiful Committee (PMBC)

The Philadelphia More Beautiful Committee (PMBC), a part of the Streets Department's Sanitation Division, began 53 years ago as a "Clean-Up, Paint-Up, Fix-Up" initiative. Over the years, this initiative has evolved into an urban environmental partnership between city government and 6,500 Block Captains and their organized blocks. PMBC has become the most workable approach to combating neighborhood grime with organized block cleanings and beautification efforts, and has grown to be one of the largest volunteer organizations of its kind in the country.
